SADDLE CONSIGNMENT AGREEMENT

This Consignment agreement is hereby entered into between Rice Saddlery, LLC, hereinafter referred to as "Consignor"; and _____ hereinafter referred to as "Owner".

The parties agree to the following Consignment Terms, as witnessed by their signatures below;

Terms:

1. Owner places his/her saddle (as described in Saddle Network Form, attached) in the possession of Consignor for the purpose of sale.
2. Owner and Consignor will come to a mutually agreed upon suggested sale price for Owner's saddle listed for sale. Saddles will be priced in accordance with market conditions at time of consignment. Consignor reserves the right to implement price adjustment of saddle(s), and agrees to notify Owner of any such adjustment. Saddles with excessive wear, fatigued leather or otherwise deemed unsafe will not be accepted for consignment.
3. Saddles sent to Consignor which are in need of cleaning and conditioning and/or photos, will be prepped for sale at cost of Owner of \$30.00. This fee will be due regardless of whether saddle is sold by Rice Saddlery and will either be deducted at time of sale or at time when owner removes saddle from consignment.
4. Owner agrees that if said saddle(s) is sold through Consignor's network, he/she shall pay to Consignor 20% commission on the sale price of the same. Commission is based on sales price and will be withheld from proceeds by Rice Saddlery, LLC upon completion of sale. If sale is not complete, there will be no charges to Owner, other than shipping or return expenses to get saddle(s) back to Owner (and/or sales prepping charges if warranted as stated in Paragraph 3 above).
5. Consignor agrees to diligently market Owner's saddle(s) to the best of its ability for the minimal period of 6 months (or other mutually agreed upon time frame in writing).
6. Both parties agree that this Agreement may be terminated at any time by either party; or that shipping and/or return expenses of saddle(s) to Owner are the responsibility of Owner.
7. Owner agrees that the consigned saddle(s) may be removed from the Consignor's store on a trial basis for a period of up to 5 days, by potential buyers. The Owner acknowledges that some wear and tear may occur while on consignment. Owner also agrees that Rice Saddlery will not be responsible for the loss or damage to the saddle(s) while on consignment, in transit or on trial.
8. Consignor agrees to forward payment for the net sales amount, less commission, and cleaning fees if warranted, to Owner within seven (7) days of completed sale.
